The excerpts of the interviews should be written in a single space using quotation mark. The discussion should be supported with more current sources and more information should be added regarding AFL in Indonesia and should be discussed comprehensively by presenting the facts of AFL barriers implementation in Indonesia. In conclusion, I would like the author provide clear suggestion and recommendation. More proof reading should be done to ensure the correct use of language

The article has been written well, but please revise the following issues:

Abstract

Good, and well-written but missing the information on who the participants are and how/why they are selected

Intro

Good, but you need to add some previous studies and draw the gap; and explain why do you think it is worth doing and applicable for the Indonesian context-page 2; please add references in page 4 in "Application of these strategies in class is not without constraints. Contextual influences play determinant roles in shaping teachers whether to use these strategies in class". Who said that 'contextual influences' significantly influential.

Methodology

Explain the rationale you chose those participants as you selected them purposively-clarify what sampling technique you used, purposive or snowball. Expand your description of data collection techniques used...Describe in more details how you refer to the participants

Findings

Good: but expand the external to school influence data
